- II. Information & Discussion Items
  - a. Day at the Capitol Follow Up

## b. Special Education Program Review

Cliff shared that SWWC plans to convene the Special Education Advisory Committee to discuss trends we are seeing with our special education program. More and more we are being asked to "customize" our approach to how we are delivering special education administrative services to our schools. Our goal is to ensure we meet the needs of the members, including making any changes in how we deliver services if that is what members want.

If you have an interest in communicating comments, concerns, or questions, contact a member of the Special Education Advisory Committee or the Executive Director. This is the beginning stages of the program review with more to come.

c. Cooperative Facility Lease Levy Discussion SWWC has been using the lease levy authority under MN law as a source of revenue to pay for new and existing facility leases for past 3 – 4 years. The current formula includes a flat fee charged to all districts plus a per pupil amount. The Council reviewed the current practice, along with other formula options; including, using a formula based on a per pupil amount that aligns with the Cooperative Facilities Levy authority in statute (\$65 per pupil).

The Executive Director recommended to use only the \$65 /APU Lease Levy Authority for cooperative facilities, to not access the \$212/APU levy authority reserved for school district use, and to use a per pupil formula amount to determine the allocation per district.

It should be noted that the use of the Cooperative Facilities levy authority is not mandatory for members, however, each member will be allocated a portion of the cooperative facility lease costs and can determine how they want to pay for these costs. The Cooperative Facilities Levy is one source for each member.

**Motion:** Motion by Ryan Nielsen, second by Todd Holthaus, to recommend that beginning with the 2025-26 budget, the SWWC Board of Directors change the formula for allocating lease costs to members from the current 40% fixed cost and 60% per pupil cost, to a straight per pupil cost, with a not to exceed allocation of \$65 per pupil as established in Minnesota statute.
