

January 6, 2025	<b>Deadline:</b> Last day for districts to submit appeal/additional information for FY 24 LTFM Reconciliation Process (see: similar dates for future fiscal year LTFM Reconciliations).

December 1, 2025	Due date for Audited Final UFARS Data Submissions (Statutory deadline of November 30, 2025 falls on a weekend, so the next business day is Monday, December 1, 2025 (Minn. Stat. 474A.025[2024]).
December 4, 2025	<b>Second Preliminary Review -</b> a revised 1) FY 2025 LTFM Approved-UFARS Cost Reconciliation Report and 2) 24-25 LTFM Aid Entitlement Report will be available to districts using final audited UFARS data and any updated revenue and approved project costs.
December 11, 2025	Last day for districts to modify approval of FY 2025 Health and Safety projects on the Health and Safety data submissions website. All projects identified after this date for work claimed in FY 2025 will not be honored and processed.
December 15, 2025	<b>Deadline</b> for FY 2026 Facilities Age and Square Footage Reporting.
December 18, 2025	<i>Final Review notice</i> sent for review and approvals of the FY 2025 LTFM Approved vs. UFARS Cost Reconciliation Report and 24-25 LTFM Aid Entitlement Report. Last day to submit an appeal is January 5, 2026 (See January 5, 2026 calendar date below).
